Career Summary

André joined the higher education sector for the first time on a full-time professional basis in October 2008 when he became the Director of the Transdisciplinary Programme at the University of Fort Hare. Between 1996 and 2008, he worked in and with independent public institutions responsible for navigating the crucial transitional phase in South Africa's contemporary history, whilst also teaching part-time and on a visiting basis at universities across the country. Much of his post-1994 work focussed on processes aimed at deepening democracy, social justice and the promotion and protection of human rights. André merges astute executive management, intellectual creativity, strategic leadership and vast practical experience into an industrious combination.

Joining the South African Human Rights Commission in 1996, André later became its Deputy Chief Executive Officer. On a unanimous recommendation from parliament, the president appointed André as a part-time Commissioner to the Commission for Gender Equality in 2008. Proficient in engaging at grassroots, community, organisational, management, strategic and executive levels, André maintains his links to the human rights structures of the United Nations and the African Union in addition to his work that is linked to ministerial appointments, state agencies and organs, civil society organisations and social movements. He is a frequently invited speaker at South African universities and universities abroad, as well as at academic conferences.

André's first professorial appointment was as an adjunct-professor at the University of Pretoria in 2009; this was followed by professorial appointments at the University of Fort Hare in 2010 and the University of the Free State in 2011, where he is currently based as the Director of the Institute for Reconciliation and Social Justice, and, until recently, as an advisor to the Rectorate. He was also appointed to serve as the Acting Vice-Rector (Student Affairs and External Relations) from June 2016 to January 2017. André serves on various structures in the human rights and higher education sectors, including his position as chairperson of the Centre for Educational Rights and Transformation (CERT) at the University of Johannesburg; member of the Ministerial Committee on Higher Education Transformation in South Africa; member of the Council on Higher Education (CHE); member of the Higher Education Quality Committee (HEQC); member of Universities of South Africa (USAf) – Transformation Managers Forum; a social cohesion advocate for the Department of Arts and Culture; and member of the Stellenbosch University Council.

Originally from Kylemore in the Stellenbosch region, André is acknowledged as a productive social justice researcher, higher education practitioner and academic citizen. He conducts peer-reviews for national and international journals; lectures on a visiting basis at national and international universities; serves as an external examiner for Masters and Doctoral studies at universities across the country; and is a peer assessor for the National Research Foundation (NRF). His research and postgraduate supervision focus on four areas: critical studies in higher education transformation; social justice, social cohesion and reconciliation; human rights, democracy and citizenship education; and public participation, critical citizenship and democracy development.
