

The Faculty of Law admits candidates to the degrees of Master of Laws (LLM) and Doctor of Philosophy (PhD). All postgraduate degrees are offered by full thesis only. Please note, however, that the Faculty does not offer any postgraduate coursework programmes. The General Rules applicable to Master's and PhD students can be found in the University's calendar.

When the award of the degree with distinction is under consideration, examiners are asked to look for evidence of real methodological and conceptual skills, clarity of exposition and development of argument, sound judgment, originality of approach, and some contribution to knowledge, and require that the thesis should reflect literary skills appropriate to the subject. The length of a Master's thesis should be between 150 and 200 pages, including footnotes. The maximum number of words for a Master's thesis is 50 000, ie approximately 200 pages.

Doctoral thesis differs from a Master's thesis particularly in respect to this point. (A) In addition, the thesis must be satisfactory as to literary style and presentation. A PhD thesis cannot be merely a collection of published papers, nor may such published papers be included as annexures or inserts. There is no maximum number of words for a PhD thesis, but it is recommend that it should be in the region of 100 000 words, ie approximately 350 pages, including footnotes.

IMPORTANT INFORMATION

ADMISSIONS

Candidates may apply in the ordinary way at any time and will be considered on an ad hoc basis, although the timing of this process could impact in which year the student is first registered and student fees.

Candidates are required to complete:

- The standard university admissions form, which can be obtained from the Registrar's Division;
- The Faculty's Postgraduate degree questionnaire.

ADMISSION CRITERIA

Academic merit

For admission to Master's, a student must have at least 65% average in his or her final LLB year. The minimum criterion is the same for PhD candidates, but preference will be given to candidates who have a Master's degree, and who provide evidence that they have some research background.

· Viability of the research topic

The topic must have sufficient scope for the proposed research.

- Select a topic:
- that is relevant to your short-term or medium-term career prospects;
 that you find intellectually stimulating and which will hopefully sustain your interest for a lengthy period;
- that is researchable, ie that can be completed with the resources that are available and at the acceptable level of scholarship.

Supervisory availability

The availability of a member of staff with some expertise in the broad field of the research.

Supervisory capacity

There is a limit to the number of candidates one person can supervise, so in some instances applications may have to be rejected because a supervisor who would ordinarily be suitable is overstretched.

THE RESEARCH PROPOSAL All admitted LLM and PhD candidates must submit a de

All admitted LLM and PhD candidates must submit a detailed research proposal, which will initially be scrutinised and approved by their supervisors. Supervisors may require candidates to redraft their proposals until the requisite detail and depth have been achieved. Candidates are then required to submit their research proposals for consideration by the Law Faculty Higher Degrees Committee which will recommend acceptance or otherwise of the proposal to the Law Faculty Board. Candidates who intend to conduct surveys as part of their research must familiarise themselves with the University's Ethical Standards Policy and obtain the necessary clearance from the Law Faculty's Ethical Standards Committee.

SUBMISSION DATE

The due date for submission of proposals is the end of March. Where a candidate does not submit his or her proposal timeously, the Higher Degrees Committee will require the candidate and supervisor to give reasons for the failure to meet the deadline and thereafter it may recommend to Faculty either that the deadline be extended or that the candidate's registration be terminated.
