1. INTRODUCTION

1.1 Overview

A basic knowledge of taxation is fast becoming a selling point for prospective employers, not just in law firms. Accounting and audit firms are recruiting law graduates with knowledge of taxation for employment in their legal compliance departments. The Law of Taxation and Estate Planning elective is aimed at providing candidates with a basic theoretical knowledge of certain important aspects of the Income Tax Act 58 of 1962, and the Tax Administration Act No. 28 of 2011 In particular, attention is drawn to the following:

- Gross Income Definition (Section 1 of the Income Tax Act No 58 of 1962 "the Act")
- Special inclusions in gross income (Section 1)
- **Selected** exemptions applicable to individuals
- Trade deductions (specifically Section 11(a))
- Prohibited deductions (Section 23)
- **Selected** special deductions (contained in Section 11)
- Qualification for taxation as a small business corporation (SBC)
- Introductory elements of capital gains tax, especially with regard to property transactions
- Introductory elements of Tax Administration
- Tax planning and anti-avoidance provisions (Sections 80A-L), 103(2) & (5))
- Anti-avoidance in estate planning (Sections 7 & 25B)
- Donations tax (Sections 54 56,7C)

The purpose of the course is to provide students with a basic knowledge of the income tax system in South Africa. The course is offered at as an elective in the final year of the LLB program in the Law Faculty.

1.2 Credit Value

This course has a credit value of 30. Students will be expected to spend at least 300 hours of study time on this course, although extra time is recommended and encouraged. This includes time spent in lectures.

1.3 Assumptions of Prior Learning

It is assumed that students have the ability to present an informed, logical argument, given a specific set of circumstances. As the course is theoretically founded, students are not required to be proficient in the use of financial calculators, nor are students required to perform detailed calculations. **Basic** calculations may be required from time to time in order to support or substantiate an argument.

2. OUTCOMES

2.1 Critical Cross-Field Outcomes

Students will be able to:

- a. identify and solve problems
- b. collect, analyze and evaluate information
- c. communicate effectively
- d. recognize problem solving contexts
- e. explore education and career opportunities
- f. develop entrepreneurial opportunities

2.2 Specific Intended Outcomes

On completion of this course students will be able to:

- Interpret the definition of "gross income" in Section 1 of the Income Tax Act (as it applies to residents and non-residents) and determine the taxability of a receipt and the nature of such receipt.
- Identify special inclusions in gross income.
- Identify certain specific exemptions contained in section 10 of the Income Tax Act
- Determine the income tax deductibility of different forms of expenditure in carrying on a trade (the "general deduction formula" in section 11(a)).
- Determine the availability of selected special capital and other allowances are available to taxpayers and in what circumstances such deductions are available (in terms of sections 11 and 11A).
- Determine "income" and "taxable income".
- Identify a small business corporation for income tax purposes and discuss the various tax concessions that are available to such entities.
- Determine the circumstances in which an individual or corporate would be liable for capital gains tax on the disposal of selected assets (in terms of the eighth schedule to the Act).
- Apply relevant provisions of the Tax Administration Act.

- Discuss certain anti-avoidance provisions contained in sections 7, 23 and 80A-L, 103(2) & (5), and their applicability to individuals in the context of tax planning and tax avoidance.
- Discuss the applicability and effect of the provisions of sections 7 and 25B on the use of trusts in estate planning.
- Discuss the incidence of donations tax as contemplated in sections 54 to 56, and 7C of the Act.

3. TEACHING METHODS

Given the current COVID-19 pandemic, all interaction will be online. Notes, Voiceover recordings, tut material, solutions and past assessments will all be made available online, via RU Connected, as well as other SARS-related reference documents and online databases. A Reading list for the course is provided.
