ATTENDANCE, APOLOGIES & ABSENTEES

- APOLOGIES:

 - Secretary General reported that Sports and Societies Councilor was absent from this meeting owing to the need for him to study for tests he was writing
 - President objected to the legitimacy of this excuse because all other Councilors also had academic commitments which were forgone for the purposes of the present meeting
 - Student Benefits Councilor noted that Sports and Societies Councilor had information to submit for the present meeting related to the disciplinary procedures to be instituted against Nkoli-Fassie
- PRESENT:

CONFIRMATION OF MINUTES OF 27 SEPTEMBER 2018

- Student Benefits Councilor noted that the vote in respect of Nkoli-Fassie reflected an inaccurate outcome: the Council had NOT voted to disband the society; instead it had voted to SUSPEND the society
- Mr. Ofei requested that the minutes be sent 24 hours before the commencement of the next meeting
- Student Benefits Councilor requested that the minutes be published as and when they are confirmed by the Council
- Minutes confirmed pending correction of errata by Student Benefits Councilor, with Treasurer General concurring

MATTERS ARISING

- Khensani

RUCE Fun Day

 Community Engagement Councilor reported that RUCE will be holding a Fun Day on 10 October 2018 at 14h00 – 15h00 with venue to be confirmed; she requested that Council members attend if they are able to do so; she noted that it would be a good opportunity for the Council to network and establish good public relations

LEAVERS

- Projects Manager began by recapping the decision taken by Council in the previous meeting; she reported that the departure time from campus to East London would be 09h00 on Saturday 20th October 2018, with return at 15h00 on Sunday 21st October
- Secretary General announced that owing to other commitments he might have to travel separately and join the Council in East London
- Projects Manager reported that Executive had proposed not to hold the leavers function with the DSA and Council substructures owing to lack of funds
- Student Benefits Councilor noted that while some Council substructures have met with their different coordinators, they are nonetheless substructures of the entire Council
- Treasurer General reiterated the financial situation citing that there were insufficient funds to hold a leavers function with the entire Council, the DSA and its substructures
- Council resolved for Treasurer General to speak with the DSA to fund the leavers function which includes the Council substructures

KHENSANI

- President reported that she was approached by a friend of the late Khensani Maseko requesting information on the progress of the case
- President noted that she was not sure that it was the Council's job to communicate such information; nonetheless a follow-up would be done on the case
- President reported that most of Khensani's friends are not coping or being helped at the Counselling Centre

- Mr. Ofei reported that the last thing he had heard in respect of the case was that the accused had been served papers of suspension; the DSA was in the process of compiling a report in the week or two prior to the present meeting
- Mr. Ofei noted that the case was a very complex one; he noted that the NPA would only proceed with a given case if there exists prima facie indications of success, and in respect of the case of Khensani, nothing had come up so far
- Mr. Ofei noted, in respect of the Counselling Centre, that they are inundated, and that the best thing that the Council can do is to guide students to the Counselling Centre if they require help
- President also noted that the Counselling Centre is for short terms support
- Student Benefits Councilor suggested that the students in question meet with their Deans for academic support
- International Affairs Councilor asked what the Wardens of the various residences are doing to support the students
- President noted that Wardens are not trained psychologists, however Wardens are in the position to offer intermediary support and to give supporting documentation for students who need it
- President also noted that need for the Council to visit Allan Gray residence
- Mr. Ofei noted that the Council ought to speak with the Senior Student/Sub-warden
 - Treasurer General to assume this responsibility and to communicate the relevant information on the Council's WhatsApp group

STUDENT DEVELOPMENT AND SUPPORT OFFICER

- Mr. Ofei reported that the coming week would be a joint meeting with the incoming Council of 2019
- Mr. Ofei reported further that he has an appointment with the lawyers in town in respect of the case with Nkomozakhe
- In respect of SRC photos, Mr. Ofei noted that the Council would have to update the collection of photos in the RA Room, and that this would have to be the duty of the Secretary General; there would have to be a day dedicated for the Council to take a photo as a group
